



## **PRIVACY POLICY**

**Welcome to the Certification Institute for Research Quality (CIRQ) web site.** We at CIRQ are committed to maintaining the privacy and security of the Personal Information of all the visitors to this web site. As a part of that commitment, CIRQ provides this privacy policy to inform our visitors about the information we collect about them, why we collect it, and where it goes. **At this web site,** CIRQ does not actively initiate any collection of any individual information. We passively collect information that is automatically sent to us by your web browser. This information typically includes your domain name (the site after the @ in your e-mail address). It may also contain your user name (the name before the @ in your e-mail address). The amount of information sent depends on the settings you have on your web browser; please refer to your browser if you want to learn what information it sends. At this page we do not actively seek to identify any individual visitor, with the exception of investigating security breaches or cooperating with authorities pursuant to a legal matter.
